# 常設授權(客戶款項)Standing Authority (Client Money)

# 1. 定義

除非另外說明,否則本授權之詞語與語句與《證券及期貨條例》(「證券及期貨條例」)及《證券及期貨(客戶款項)規則》不時修訂之定義 具有相同意思。

#### 2. 本授權

下述簽署人謹此授權正大國際金融控股有限公司按下列方式自行酌情處理本人/吾等於貴行之期貨賬戶內代收或代持有任何數額之款項而無須事先給 予下述簽署人任何事先通知或事先取得下述簽署人的指示及/或確認:

- (i) 將任何數額之客戶款項轉往正大國際金融控股有限公司於其代理經紀及/或清算代理(不論該代理是否貴行之系內公司或處於香港或其它地方)以買賣或清算/結算客戶的期貨或期權;及
